# TECHNICAL DATA

## FOREMOST 4884-ES INSECTI-MIST

Rev. 4-2-14

**DESCRIPTION:** An effective pyrenone insecticide in aerosol designed for use in automatically-time discharging devices which gives a dosage of 100 mgs. set to discharge every 15 minutes. One unit will control houseflies, mosquitoes, gnats and flying moths in an area of approximately 6,000 cubic feet. Factors such as shape of area, temperature, humidity and air currents all affect insect activity and may modify the exact area protected. Insect control will build up within 2 hours after unit is in operation.

Used as directed, this can contains sufficient insecticide to be operated 24 hours a day for 34 days. This will provide for monthly replacement. Any remaining contents may be used manually.

**APPLICATION:** Recommended for use in food processing plants, restaurants, hospitals, nursing homes, stores, hotels, motels, schools, and other public buildings, in dairies, barns, farm milk houses, canneries, breweries, and food handling establishments.

**DIRECTIONS:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

**TO USE AUTOMATICALLY:** Place aerosol in FM 9576 Measure-Mist Dispenser. Using the metered valve provided, which gives a dosage of 100 mgs., set to discharge every 15 minutes.

**TO USE MANUALLY:** Remove cap and direct spray at flies or other insects, pressing the activator button repeatedly. To treat entire area, close windows and doors and press activator button 7 times per 1000 cubic feet of space while moving about to distribute the spray in the upper portion of the room. Keep room closed for 15 minutes and ventilate before reoccupying.

Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using this product in these areas, apply only when the facility is not in operation.

**PRECAUTIONS:** **KEEP OUT OF REACH OF CHILDREN. HAZARDOUS TO HUMANS AND DOMESTIC ANIMALS.** Harmful if swallowed or absorbed through skin. Avoid breathing vapors. Avoid contact with eyes, skin or clothing. In case of contact, immediately flush eyes and skin with plenty of water. Get medical attention if irritation persists.

Do not use in nurseries or rooms where infants, ill or aged persons are confined.

**STORAGE AND DISPOSAL:** **Storage:** Store in a cool area away from heat or open flame. **Disposal:** Replace cap and discard container in trash. Do no incinerate or puncture can.
