DESCRIPTION: A ready-to-use, non-caustic, water soluble, liquid cleaner formulated for fast and efficient removal of oil, grease, dirt deposits, grime, cutting oils and other contamination. It is harmless to sound paints and safe on all metals including aluminum. Effective results produced through a combination of chemical and physical actions by penetrating, emulsifying, wetting and water softening.

APPLICATION: Recommended for industry, food processors, institutions, automotive, building maintenance, restaurants and all washable surfaces such as walls, appliances, porcelain, automobiles, stainless steel, plastics and vinyl, exhaust fans, all kitchen surfaces and lockers.

DIRECTIONS:

1. Apply cleaning compounds to surface by spray; trigger foamer, brush or mop.
2. Agitate if needed, or simply;
3. Rinse or wipe off.
